## **Community Grants**

**Motion 1:** The Grants & Rebates Committee moves to approve funding not to exceed **\$5,000** from line item **1.10 (Community Grants)** for WPBCC to fund marketing and supplies for the 2024 WPB Winter Wonderland. (24-1001)

*Discussion: MH confirmed with AH that the event would be free to the public, as the grant application did not specify.*

**Motion 2:** The Grants & Rebates Committee moves to approve funding not to exceed **\$5,000** from line item **1.10 (Community Grants)** for WPAC to fund artist stipends and materials for their 2025 Summer CREATE Series. (24-1002)

*MH motions. EC seconds. All ayes. **Recommendation passes.***

**Motion 3:** The Grants & Rebates Committee moves to approve funding not to exceed **\$5,000** from line item **5.03 (Security Patrol Services)** for Endless Supply to assist with on-site security patrol services (24-1003)

**Motion 4:** The Grants & Rebates Committee moves to approve funding not to exceed **\$5,000** from line item **5.03 (Security Patrol Services)** for Inn Joy to assist with on-site security patrol services (24-1004)

*Discussion: MH and EC requested that the total expense of security costs for Inn Joy be calculated for the year, so the security rebate percentage can be verified before being approved by Commission. MH and EC made the same request for Round Two.*

**Motion 5:** The Grants & Rebates Committee moves to approve funding not to exceed **\$5,000** from line item **5.03 (Security Patrol Services)** for Round Two Vintage to assist with on-site security patrol services (24-1005)

**Motion 6:** The Grants & Rebates Committee moves that the maximum individual reimbursable amount for the Safety Rebate be increased from \$1,000 to \$2,000 under line item **5.02 (Safety Improvement Program Rebates)** in 2025. (24-1006)
