*DG discussed the future status of the “Transmigration” sculpture in Mautene Court Plaza, as the wood material is currently rotting and could become a hazard. After debating the merits of its disposal, replacement, or relocation, and after an informal vote, the Commission recommended to remove the sculpture for the time being and request a quote from the artist to repair it with sturdier material and place it back in Mautene Court Plaza.*

**Motion 1:** The Commission moves to approve funding not to exceed **\$62,000** from line item **2.02 (Landscaping)** for Bartlett Tree Experts to perform annual pruning, maintenance, and inventory. (25-0604)

**Motion 2:** The Grants & Rebates Committee moves to approve funding not to exceed **\$5,000** from line item **1.02 (Special Events)** for WPBCC's Wicker Park Fest to assist in funding marketing expenses. (25-0601)

*DH motions. WJ seconds. All in favor. **Motion passes.***

**Motion 3:** The Grants & Rebates Committee moves to approve funding not to exceed **\$5,000** from line item **1.10 (Community Grants)** for Bucktown Community Organization's Garden Walk to assist in funding artist stipends and marketing expenses. (25-0602)

*Discussion: AH clarified that BCO had forgotten to submit the grant in the previous year, but the Commission has approved this grant in years past.*

*DH motions. WJ seconds. All in favor. **Motion passes.***

**Motion 4:** The Grants & Rebates Committee moves to approve funding not to exceed **\$5,000** from line item **1.10 (Community Grants)** for Round Two's Back to School Drive to assist in funding marketing, supplies, and stipend expenses. (25-0603)

*Discussion: The Commission was skeptical of the event's impact on the immediate community, and LB recommended that the event be shared with local schools and the 1<sup>st</sup> Ward office to make sure it most directly impacts WPB.*

*DH motions. WJ seconds. All in favor. **Motion passes.***

- a) WJ remarked that the orange planters had been repainted, but that they did not quite cover the graffiti beneath, recommending a second coat
- b) WJ also revisited EcoFest, a Special Events initiative that SSA 33 used to manage, and requested that the committees and Commission revisit the idea for future activation to better focus on sustainability.
